Zoning board hears two cases

CANTON — The Canton Zoning Hearing Board held two separate hearings on zoning issues for the Canton Moose Lodge and Brian and Amy Koval, on Monday, March 18.

The Canton Moose Lodge was seeking a Variance to the Zoning Ordinance with regards to their digital electronic sign.

Scott Palmer and Jim Colton were sworn in to testified on behalf of the Moose, along with Amy Seeley who testified on behalf of the Board.

Seeley testified the sign at the Moose violates the current Ordinance. It does not meet the regulations on the 500' from a traffic light intersection, which it is only 281' from the light, and 500' from a residential use, which is across the street, below the Moose, but still within 500'. Also, the maximum dimension requirements for the area of the sign is larger than the Zoning Ordinance allows, with having an area of 20 sq. ft. and the Ordinance only allows up to 12 sq. ft.

Colton indicated it was exactly the same size as the original one, although that one was not electronic.

Seeley advised she issued a zoning permit for static use. There were times after that in which the sign was being used as transitional (a moving message) and it was stopped after she so requested.

Palmer inquired if any complaints have ever been received, to which Seeley responded no.

Barrett directed to the Moose that they should not advertise on the sign for favors or money for any other organization or it will violate the Ordinance.

Colton stated the sign can be adjusted for brightness, which they did according to PennDOT's regulations for driving visibility and PennDOT indicated no permit is required.

The Solicitor and Board adjourned to a different room to discuss and reach a decision, after which the Board reconvened.

Mott behind two months on restitution

CANTON — The Canton Borough Authority met on Tuesday, March 12 at the wastewater treatment facility.

The last monthly restitution payment the CBA received from Brenda Mott from Bradford County Collections was in the amount of \$1,200, for restitution for December and January.

Payments for February or March have not been received as of this meeting.

The total amount of money that Mott has returned thus far is \$131,595.21. The total balance due according to the Civil Suit Agreement is \$196,488.69.
